This Certifies that the herein described appliance has been tested by THE AUSTRALIAN GAS ASSOCIATION (hereinafter called the Association) and found to comply with the approval requirements of the Association. This Certificate of Approval covering the appliance listed herein (hereinafter called the "Certificate") entitles the manufacturer or his agent (whose names appear hereon), to affix the Badge of Approval endorsed hereon to every appliance of the model herein described during the currency of the Certificate. The Certificate holder shall not affix the Badge of Approval to any appliance that is not a reproduction (within prescribed or (if none be prescribed) generally acceptable manufacturing dimensional tolerances) of the appliance for which this Certificate is issued.

The Association may at its discretion and without assigning any reason therefore at any time during the currency of the Certificate recall and/or cancel this Certificate and the licence of the manufacturer or his agent to affix the Badge to any such appliance shall thereupon be terminated without further notice.

Subject to the Association's right of cancellation this Certificate is valid only for two years from the date of issue. On the expiration of two years, the Certificate of Approval will be recalled, and subject to satisfactory field performance of the appliance, and compliance with pertinent additions, alterations or amendments to the Approval Requirements, approval may be extended for a further two year period, without the need to satisfy the test applicable to that appliance. Renewal beyond four years will only be granted if an appliance is submitted for examination, and if required by The Australian Gas Association, is tested for conformity with any or every relevant section of the approval requirements, as then in force.

The Certificate is issued on the express conditions: —

1. That all appliances sold by a manufacturer or his agent, which are covered by this Certificate of Approval, must carry The Australian Gas Association's Badge of Approval. These Badges shall be obtained from the Association and shall be used by the manufacturer or his agent in accordance with the terms and conditions set out herein or with such other terms and conditions as shall from time to time be prescribed by the Association.
2. That the Certificate holder will afford all reasonable facilities for persons authorised by the Association to examine appliances, etc., in respect of which this Certificate is issued.
3. Any manufacturer or his agent who, in his efforts to sell an appliance bearing the Badge of Approval of the Association, exploits or represents such Badge as anything more than a guarantee of compliance with basic requirements for safety, efficiency and durability, will be liable to the cancellation of the Certificate of Approval under which such appliance had been badged.
4. That neither the Association its Board nor officers shall be liable at the suit of the manufacturer or his agent (whose names appear hereon) to any claim for damages or by way of indemnity arising out of any contract for the sale of any appliance to which a Badge of Approval is affixed as aforesaid or arising out of the use of any such appliance whether the Association its Board officers or servants have been negligent or otherwise.

In the event of a manufacturer wishing to alter the specification referring to this Certificate, he undertakes to inform the Association of such alterations in time for tests to be carried out before production begins.
